Our largest educational program is our guided bus tours. Visitors take 45 minute bus tours of Dinosaur Ridge. Approximately 12,000 visitors took such bus tours at Dinosaur Ridge in 2020. The number was much less than in typical years, which average about 34,000, because of the pandemic's regulations on enclosed spaces and social distancing.

4b (Code:) (Expenses \$ **89,650** including grants of\$) (Revenue \$ **19,044**)

In a typical year, our guided school tours programs host hundreds of school and other institutions each year for 90 minute bus tours. Students and their teachers tour Dinosaur Ridge each year with their classmates (sometimes multiple classrooms at a time). Because of the pandemic, school tours were slowed significantly, so we added virtual tours to our program menu. Approximately 5,000 students toured Dinosaur Ridge either live or virtually in 2020.

Our Summer Camps are intensive one-week experiences for 6-to-12 year olds, who study and discover the world of palenotology and geology at Dinosaur Ridge. In 2020, 184 childrent spent a week of their summer with us. Our Summer Camps adapted to the strictures of the pandemic, and attendance was close to normal.

However, it only recently was brought to the attention of the Organization that the return that the prior accountant said was filed, was never actually submitted as stated. The Organization had employed the prior accountant for many years, and earlier in the year, but she was unable to continue her service due to personal reasons. The Organization has been unable to effectively communicate with her since.

It was not until the Organization received a notice of non-filing that we became aware that neither the return nor the extension had been filed for the year ending 9/30/20. The organization immediately retained a preparer and had the return redone. The 9/30/21 return will be e-filed in a timely manner, as will all future returns. We respectfully request that you abate the penalties and interest for late filing, as the Organization genuinely believed that the prior accountant had filed the return as stated. We will take extra steps to ensure that this doesn't happen again in the future.
