We practice responsible stewardship with a strong commitment and urgency to preserve the fossils and nature resources for future generations. Dinosaur Ridge is designated by the National Park Service as a National Natural Landmark. Our goals are accomplished by encouraging and assisting in scientific research, through the development of educational programs, and through the exhibition and preservation of fossils. In the 12 months ended September 30, 2021, approximately 230,000 people visited Dinosaur Ridge, approximately 50% of whom came from outside the Denver-Boulder metro area. The Organization's revenue is largely based on our visitors spending on gift shop items, bus tours, and other programs which were significantly impacted by the pandemic restrictions during the first half of the fiscal year. The Organization responded by adding a number of additional virtual programs, including audio and virtual tours, which have already been accessed by thousands of remote guests.
