

Our goals are accomplished through the development of educational programs, through the exhibition and preservation of fossils. We also support scientific research on Dinosaur Ridge. In the 12 months ended September 30, 2022, approximately 206,000 people visited Dinosaur Ridge, approximately 50% of whom came from outside the Denver-Boulder metro area.
