WE PRACTICE RESPONSIBLE STEWARDSHIP WITH A STRONG COMMITMENT AND URGENCY TO PRESERVE THE FOSSILS AND NATURAL RESOURCES OF DINOSAUR RIDGE FOR FUTURE GENERATIONS. DINOSAUR RIDGE IS DESIGNATED BY THE NATIONAL PARK SERVICE AS A NATIONAL NATURAL LANDMARK. THESE GOALS ARE ACCOMPLISHED BY ENCOURAGING AND ASSISTING IN SCIENTIFIC RESEARCH, THROUGH THE DEVELOPMENT OF EDUCATIONAL PROGRAMS, AND THROUGH THE EXHIBITION AND PRESERVATION OF FOSSILS. IN THE 12 MONTHS ENDING SEPTEMBER 30, 2025, APPROXIMATELY 215,000 PEOPLE VISITED DINOSAUR RIDGE, APPROXIMATELY 50% OF WHOM CAME FROM OUTSIDE THE DENVER-BOULDER METRO AREA.
